THIS INFORMATION IS THEN REVIEWED BY TWO SEPARATE COMMITTEES: THE COMMITTEE ON MEMBERSHIP REVIEWS THE ORGANIZATIONAL & PROGRAMMATIC INFORMATION, AND THE FINANCE COMMITTEE REVIEWS THE FINANCIAL INFORMATION. THESE COMMITTEES REPORT THEIR FINDINGS BACK TO THE EXECUTIVE COMMITTEE & THE BOARD OF DIRECTORS TO ENSURE THAT ALL MEMBERS REMAIN IN COMPLIANCE.
