EACH MEMBER ORGANIZATION IN GOOD STANDING HAS ONE VOTE. AT LEAST 60% OF THE BOARD OF DIRECTORS IS COMPRISED OF MEMBER DIRECTORS AND AT LEAST 20% ARE COMMUNITY DIRECTORS. THE BOARD OF DIRECTORS ELECTS OFFICERS (PRESIDENT, VICE PRESIDENT, SECRETARY AND TREASURER) AND ORGANIZES COMMITTEES. IN ADDITION TO ELECTING THE BOARD OF DIRECTORS AND ADDING NEW MEMBER ORGANIZATIONS, THE MEMBERS RETAIN THE RIGHT TO TAKE ACTION REGARDING THE SUSPENSION OR TERMINATION OF CURRENT MEMBERS AND ENACT AND/OR AMEND THE CODE OF REGULATIONS/BY-LAWS.

## **Part III – Statement of Program Service Accomplishments – Greater Cleveland Community Shares**

### **Statement of Primary Exempt Purpose:**

Greater Cleveland Community Shares (Community Shares) is a non-profit corporation providing financial and other support for its member non-profit organizations and others located in Ohio. Member organizations are actively engaged in programs directed towards community improvement, social change, and citizen education and empowerment. The principal goal is to help the member organizations raise funds through charitable workplace giving campaigns. A minimum of 85% of campaign receipts are distributed to eligible members and unaffiliated non-profits each year.

### **Exempt Purpose Achievements in Four Largest Program Areas (as measured by fund distributions):**

#### Distributions to Member Organizations

Total distributions to members and other non-profit organizations from the 2010 workplace campaign totaled \$838,395 (including donor options from United Way). The unrestricted funds provided to member organizations enable them to provide community-building and social justice programs that are often restricted by other funders. Some of these programs include addressing predatory lending, advocacy for the homeless and those without health care, protection of civil rights, fighting housing discrimination, and many other program areas. Over the 26-year history of Community Shares, these distributions total more than \$14 million.

#### Campaign

Administering charitable workplace giving campaigns in approximately 123 local work sites (companies, legal and accounting firms, schools, libraries, non-profits, government agencies) for over 125,000 employees in 2010, Community Shares raised, for the fifth year in a row, more than \$1,000,000 in pledges for its member organizations and other non-profits, including the State of Ohio Combined Campaign and North Coast Combined Federal Campaign. The State of Ohio Combined Campaign is administered by Greater Cleveland Community Shares for our organization as well as for the Mid-Ohio, Greater Cincinnati and Northwest Ohio Community Shares organizations.

The funds raised through the 2010 campaign will be distributed to Community Shares' member organizations throughout 2011. Community Shares organizations use these funds to support a variety of social justice missions, including promoting civil rights, working to break the cycle of poverty, providing job training to women and minorities, educating communities about health and environmental issues, and working to reduce violence in Cleveland's neighborhoods.

#### Community Outreach

Community Outreach in 2010 took the form of presentations to employees in the 123 workplaces where Community Shares participates in annual charity campaigns. These presentations encouraged philanthropic giving, informed employees about Community Shares' member organizations and educated them about the choices they have when making their pledges. Numerous other presentations were made to decision-makers who were considering adding Community Shares to their workplace campaigns and to board members of many of Community Shares member organizations.

Community outreach activities were also scheduled throughout the campaign season, including attendance at multiple information fairs, a campaign kickoff featuring a series of events and fundraisers throughout Cleveland during the fall campaign season, and our annual “Power Lunch” celebration of Community Shares at which we recognized distinguished activists in our community with our “Social Justice Awards” with over 300 in attendance at Windows on the River in Cleveland, Ohio and held our annual meeting of members.

#### Management and General

These items are mainly administrative in nature, paying for general supplies, postage, meeting expenses for the Board of Directors and committees, and some administrative salaries.

#### Other Program Services

##### Service to Members

Other services to member organizations include regular communication within the federation in the form of mailings, e-mail announcements and e-newsletter, and reminders. A link on the Community Shares website helps its members announce their job openings, and Shares frequently refers qualified interns and volunteers to member groups. In addition, the website and e-newsletter highlights members’ accomplishments, activities and successes. Community Shares also coordinates member relationships with Business Volunteers Unlimited (BVU) and the Ohio Association of Nonprofit Organizations (OANO) as a service. All of these member services are geared toward improving communications, promoting cooperation, building organizational capacities, and seeking economic efficiency.

##### Fundraising

Other development activities go toward supporting the operations of Community Shares. These sources of funding include foundations, individual and corporate donors, and special events. With this very efficient use of dollars, Community Shares was able to plan, develop, and implement the program initiatives listed above more effectively.

##### Donated Services

Member organizations provided over 2,500 hours of volunteer services for Community Shares, while community volunteers gave an additional 200 hours. Various individuals, institutions, and businesses donated services and products to be used as fundraising incentives and prizes.
